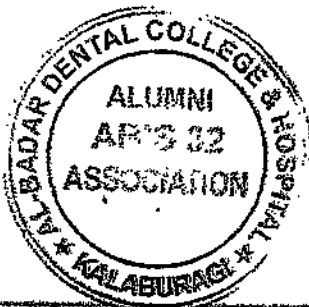


THE AIM & OBJECTIVES:

1. Name of the Society : **AL-BADAR DENTAL COLLEGE ALUMNI ASSOCIATION.**
2. Address of the society : **at al-badar dental college campus Naganalli Road Kalaburagi**
3. Area of Operation of the Society : **The entire Karnataka State**

1. Members

The association shall consist of the following persons as its members.

2. All UG, PG, Ph.D graduates and staff of the Al-Badar dental college are eligible to become members of the Association on payment of annual fee of Rs 1000/- or life membership of Fee Rs 2500/-
3. The subscribers to the memorandum shall be the patron members as well as life members of the association.
4. Any student/scholar who pays the annual subscription of Rs2500/- during his/her study in the al-Badar dental college can be considered as student member of the Association and he/she will automatically become member of the Association after passing out from the college. Taking the subscription of Rs 2500/- paid during his/her studentship as the life membership.


5 Right of Members

- a) Every member shall be eligible to participate in any or all the activities of the association.
- b) Vote of member-each member shall have only one non transferable Vote.
- c) Only life member can contest for any post of management committee.

6 Rejection of Membership

It shall be competent for the committee of management to reject any application for the membership applications within a period of two months from the date of receipt of application. If not done so, shall be deemed that the concerned membership application is accepted. 2..

- 7 Termination of membership: A member shall cease to be as such if the Member:
- i) he/she resigns
 - ii) he/she incurs insanity or insolvency
 - iii) dies/expires.
- 8 Removal of membership: management committee shall be competent for the removal of member assigning valid reason by a special resolution passed by the management committee provided it is passed by at least $2/3^{\text{rd}}$ of the members participating in the meeting called for the purpose, further the committee shall be competent, to remove any member if the Management committee, if in its opinion that such a person ought not to continue as a member on account of his utterance made or acts done, prejudicial to the best interests of the committee shall be final and binding on the person and shall not be questionable in the court of law. However, the affected person may appeal before the subsequent General body of the association for a reconsideration of the decision of the management committee.
6. **Administration**
- 1 The administration of the Association shall rest in Executive committee, Consisting of (1) a President (2) a vice President (3) secretary (4) a Joint secretary (5) a Treasurer (6) Eleven Members, All founder life members shall be the Ex-officio members of the alumni Association.
 - 2 The members of the Executive Committee shall be elected by the Members of the Association including life members and at the annual General body meeting they shall hold office for the first formed body for a three years period later for a period of two years consequently.
 - 3 A committee once elected shall continue to hold office till a new committee assumes charge.
 - 4. If any vacancy arises in any post on account of resignation, death etc. the executive committee may nominate any person to such post from among the members of the Executive Committee. Such nominated persons shall hold office till the next election of the executive committee.
 - 5 If any member fails to pay the annual subscription fees with in that year (on or before the end of the academic year,) after the same has fallen due shall cease to be member of the association and the General Secretary shall remove the name of such defaulter from the register of members. The members who miss three consecutive meetings may be removed from membership.

7 General body meeting

- 1) The General Body of the Association shall hold an Annual General Body Meeting at least once a year and not more than 18 months shall elapse between two successive Annual General Body Meetings.
- 2) A notice of at least 21 days shall be given to the members before convening a General Body Meeting.
- 3) The Secretary shall upon being requested in writing by the Executive Committee or by at least 15 members of the Association, call an Extraordinary General Meeting (EGM) for which at least 15 days' notice along with agenda shall be circulated to all the members. One third of total members or 40 members present in person shall form a Quorum for any meeting of the General Body. If the meeting is adjourned After 15 minutes for want of quorum, the meeting shall again take place after 30 minutes of adjournment to transact the same business and the members Present shall form the quorum.
- 4) The duties of the General Body shall be:
 - 1 To set guidelines for the Executive Committee so as to achieve the aims and objectives of the Association.
 - 2 To consider and adopt the Annual Report and Audited Accounts of the Association.
 3. To appoint Auditors.
 - 4 To appoint legal advisors, if any.
 - 5 To honour the distinguished Alumni.
 - 6 To elect office bearers and members of the Executive Committee.
 - 7 To transact any other business with the permission of the President in Chair.
 - 8 All the resolutions put to vote at the General Body shall be decided by a majority vote (unless otherwise provided) on a show of hands. In case of equality of vote, the President in Chair shall have the casting vote.
 - 9 Returning officer for the elections will be appointed by the Executive Committee who will conduct the election process. The guidelines for conducting the election will be decided by the Executive Committee.
 - 10 to consider any amendments to the by-laws.
 - 11 extraordinary meetings of the General body shall be convened at the request of not less than one-third of the total members, within two months after receipt of such request.

8 Executive committee Meetings


- 1 The Executive Committee shall consist of: (i) President 1 (ii) Vice President 1 (iv) Secretary 1 (v) joint secretary 1 (vi) Treasurer 1 (vii) Immediate Past President (ex-officio) 1 (viii) Immediate Past Vice President (ex-officio) 1 (ix) Immediate Past Secretary (ex-officio) 1 (x) Immediate Past joint secretary Dean Alumni Affairs or equivalent (ex-officio) 1 (xi) General Secretary of Al-badar dental college.

2 Election of the Executive Committee:

- 2 All office bearers and members of the Executive Committee except the Founding Members shall be elected/ nominated from amongst the Members. The President shall be elected by the General body.
- 3 The Vice President shall be elected by the General Body.
4. The Secretary shall be elected by the General body.
5. The Treasurer shall be elected by the General body.
6. other members shall be elected by the General Body.
7. In the eventuality of any seat left vacant, the Executive Committee will have the power to co-opt members to fill the vacancies.
- 8 The procedure for election of the office bearers of the Association shall be regulated according to the Bye-laws of the Association.
9. Each passing out Batch shall nominate one Batch Specific Member, to act as a representative of the complete graduating batch. The Specific Member nominated by the batch will be a central contact point between the Association and Al-badar dental college. At a time, Batch Specific Members for latest 3 consecutive batches shall be appointed and shall remain active.
- 10 No elected/nominated office bearer shall hold office for first formed body for three years period later for a period of two years, except under exceptional circumstances approved by the Executive Committee.
11. Returning officer for the elections will be appointed by the Executive Committee who will conduct the election process.
12. The Executive Committee will meet ordinarily every quarter, but the Secretary with the permission of President, can call an emergency meeting at any time. A notice of 15 days shall ordinarily be given to members for convening an emergency meeting.
13. The quorum for the Executive Committee meeting shall be five. In case, there is no quorum, it shall be adjourned and reconvened after 15 minutes, the number of members present will form the quorum.

14. The Executive Committee shall have all the powers with regard to management and promotion of objectives of the Association according to directives, if any, of the General Body.
15. The Executive Committee shall approve the budget for the following year. 8.8 The Executive Committee shall frame Bye-laws in accordance with Rules and Regulations, which shall be rectified by the General Body later on.
16. The Executive Committee shall manage the affairs of the Association by majority vote in the Committee Meeting provided that in case of tie, the President shall have the casting vote.

9 Powers and Duties of the Executive Meetings

President: The President shall preside over Executive Committee and General Body meetings. He or She shall have all the powers for the management and promotion of the objectives of the Association.

Vice President: The Vice President shall act as the President, in the absence of the President. He/She shall render advice to the Executive Committee with regard to promotion of the objectives of the Association.



After holding Annual General Body Meeting, the Secretary shall file the following information:



Treasurer:

The treasurer shall keep the books of accounts of the Association. He/she will collect all dues and claims on behalf of the Association and assist the President and Secretary in ensuring that budgetary grants are correctly utilized. In addition, he/she will liaise with the bankers and the Auditors of the Association.

1. Any three from amongst the President, Secretary and Treasurer shall operate the funds of the Association subject to general approval of the Executive Committee.

10 Elections

All the office bearers and members of the management committee shall be elected by the Annual general body or the special General body as the case may be.

- 10.1 The candidate shall file their nominations in the prescribed form and submit personally or registered post to the secretary of the association.
- 10.2 A screening and scrutinizing committee shall conduct election process, this committee shall consist of president. President Elect any two office bearers who are not contesting in the election. The returning officer for the election will be incumbent president Elect. all the sealed envelopes containing nominations papers shall be opened by the returning officer, returning officer shall inform all the candidates about the acceptance or rejection of the nominations after the scrutiny. Candidates desiring withdrawal shall do so in writing to Hon. secretary shall announce the names of all the candidates whose nominations are valid and accepted in the association website.
- 10.3 Hon. Secretary shall prepare the ballot paper containing names and posts of the candidates.
- 10.4 Candidates should be present during election; nominations will be rejected in case they are absent.
- 10.5 Voting shall be done by marking [X] in the space provided in the ballot paper.
- 10.6 When there is one post, candidates getting maximum number of votes will be declared elected.
- 10.7 When there is more than one post, candidates getting maximum number of votes in descending order will be declared elected.
- 10.8 The president shall have a casting vote in case of equality of votes.
- 10.9 In case of any dispute during election, the decision of the returning officer will be final and binding on all the candidates.
- 10.10 Any post /posts remaining vacant for want of nominations from the life member /candidates are absent at the time of election the elected body may appoint with 2/3rd majority.


11 Finance

- 1 The Association shall raise funds for pursuing the objectives of the Association through:
 - a) Subscriptions from the members - The rate of subscription shall be governed by the Bye-Laws of the Association.
 - b) Money donated by the members.
 - c) Any other source approved by the Executive Committee.
- 2 The accounts of the Association shall be maintained in any scheduled Bank at kalaburagi into which all subscriptions, donations and other income shall be credited.
- 3 Financial year of the Association shall be from April 1st to March 31st of the following year.
- 4 The funds of the Association may be invested in Reputed Mutual Funds and other financial instruments currently in vogue, Government Securities, Bonds and Debentures of reputed public companies, Schemes of Unit Trust of India and Banks.
- 5 The services of a reputed investment advisor may be engaged for this purpose on suitable terms.
- 6 Withdrawals from the invested funds shall be made only with the approval of the Executive Committee to be ratified by the General Body later on.


12. Audit of Accounts

The accounts of the Association shall be audited once a year by a Chartered Accountant or an equivalent Institute representative, to be appointed by the General Body.

- 1 Suit and proceedings by and against the Association the Association may sue or be sued in the name of Secretary.
- 2 No suits or Proceedings shall file by reason of any vacancy or change in the holder of office of the Secretary.
- 3 Every decree or order against the Association in any suit or proceeding shall be executable against the property of the Association and not against the persons or the property of the President, Secretary or any office bearer.




5 No member of the Association may be sued or prosecuted by the Association except for any injury or loss damage, detention or destruction of any property of the Association.

13. Amendments

Any provision of this constitution can be amended by a two-thirds majority of those alumni members present and voting in General Body Meeting. The quorum for such a Meeting will be 30 members. The proposal to amend the Constitution shall be at the instance of the signed requisition by at least 50 alumni. Notice of the proposed amendments shall be furnished to the Secretary at least 42 days before the date at which it is proposed to consider the amendments. Such a notice will contain details of the Rule (s) desired to be amended, the proposed text of the changed rule and the reason for seeking the amendment. The latter is meant as a guide for any deliberation at the General Body Meeting. Upon the receipt of a requisition for amendment the Secretary shall issue notice to every member for the meeting, at least 21 days before the scheduled date. Mandate for amendments can be sought by circulation or e-mode also in the eventuality of non-availability of sufficient members in GBM. Bye laws will be framed by the Executive Committee and can be amended by the Executive Committee.

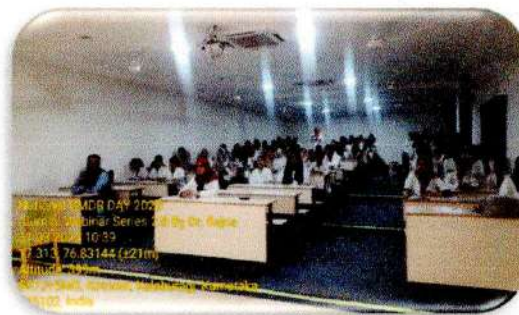

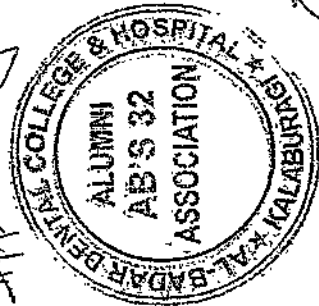
